Duration and participation

The meeting starts on Tuesday 06th of November at 09:00 and should be concluded on Wednesday 7th of November. Participants are expected to arrive on Monday 05th of November and not to depart earlier than 12:00 on Wednesday 07th of November.

Meeting Objectives

The upcoming 37th DPPI SEE Regional Meeting will have the following objectives:

- Review of the reports prepared by the CiO and the Secretariat
- Adopting the Annual Work Plan for 2019
- Adopting the Internal Operations Handbook for the Secretariat
- Adopting the DMTP 2019

Having in mind the conclusions from the first Trio Meeting, held on 4th of July 2018, it is envisaged next year DPPI SEE to develop a long term strategic plan with specific objectives and indicators to be met. The Advisory Board session is designed towards that goal.
